These expenditures are to be reported under <b>SECTION B</b> of the Agent AER. <u>REPORTABLE UNDER SECTION C of the AER:</u> All-Invited functions; report non-itemized meals/beverages for functions w here ALL legislators or ALL members of either chamber are invited. <u>REPORTABLE UNDER SECTION D of the AER:</u> <u>NON ITEMIZED MEALS UNDER \$50.00:</u> Agents may spend \$50.00 per calendar year/per reportable person without itemizing the expenditure. <u>SPEAKING ENGAGEMENTS:</u> Meals where a member is part of a panel, speaking engagement, or seminar. <u>NATIONAL CONFERENCE MEALS:</u> Meals provided at a meeting or convention of a National Organization to which the State pays dues.
