In the Court of Common Pleas, Franklin County, Ohio, of the Grand Jury term beginning January tenth in the year of our Lord, Two Thousand Fourteen.

Ron O'Brien, the duly elected and qualified Prosecuting Attorney of Franklin County, Ohio, in the name of and by the authority of the State of Ohio, says that prior to this information, John L. Rabenold was duly advised by the Court of the nature of the charge against him and of his rights under the Constitution, and he stated that he understood the nature of said charge against him and his constitutional, statutory, and procedural rights, and that he had fully discussed all aspects of his case with his attorney, Charles Rockwell Saxbe, and he was completely satisfied with the legal representation and advice and waived in writing and in open Court prosecution of the offense by indictment,

Count 1

By way of information, John L. Rabenold late of said County, on or about the 31st day of January in the year of our Lord, 2010, within the County of Franklin aforesaid, did knowingly file a false statement, To Wit: he failed to include in his report to the Ohio Joint Legislative Committee expenditures made relating to an event December 6, 2009 at a Cincinnati Bengals game made by him as a legislative lobbyist on behalf of Axxcess Financial Services, Inc. for the benefit of one or more public officials, To Wit: members of the Ohio General Assembly, in violation of Sections 101.71(D) and 101.99(B) of the Ohio Revised Code, a misdemeanor of the first degree, contrary to the statute in such a case made and against the peace and dignity of the State of Ohio.


Count 2

By way of information, John L. Rabenold late of said County, on or about the 4th day of June in the year of our Lord, 2010, within the County of Franklin aforesaid, did knowingly files a false statement, To Wit: he failed to include in his report to the Ohio Joint Legislative Committee expenditures made relating to an event January 5, 2010 at Lindey's Restaurant and January 24, 2010 at Via Vite Restaurant made by him as a legislative lobbyist on behalf of Axxcess Financial Services, Inc. for the benefit of one or more public officials, To Wit: members of the Ohio General Assembly, in violation of Sections 101.71(D) and 101.99(B) of the Ohio Revised Code, a misdemeanor of the first degree, contrary to the statute in such cases made and provided and against the peace and dignity of the State of Ohio.
