April 16, 2012	Financial Disclosure Statements must be filed by all current and former Members (during 2011) who are NOT candidates at the March 2012 Primary Election and designated staff filers of the General Assembly or any legislative agency
May 1, 2012	Deadline Reminder Postcards & Emails for Updated Post Employment Disclosure Statement(s) for Jan. – Apr. reporting period sent
May 31, 2012	Deadline for filing Updated Post Employment Disclosure Statement(s) for Jan. – Apr. reporting period
June 11, 2012	Certified letters sent to individuals delinquent in filing Updated Post Employment Disclosure Statement(s) for Jan. – Apr. reporting period. If required statement(s) not filed within 15 days from receipt, a late filing fee is assessed.
September 4, 2012	Deadline Reminder Postcards & Emails for Updated Post Employment Disclosure Statement(s) for May – Aug. reporting period sent
