January 4, 2017

January 2017

January 1, 2017- Lobbyists/Employers can begin filing September-December 2016 Activity & Expenditure Reports.

January 17, 2017- Registrations: The last day to renew all Legislative, Executive and Retirement System registrations in OLAC. Registrations filed after this date will require a signature page along with the filing fee.

January 21, 2017- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the September-December 2016 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

January 31, 2017- Activity & Expenditure Reports: Deadline for filing September-December 2016 lobbying reports.

February 2017

February 5, 2017- Delinquent lists posted to the website ([Agents](#) and [Employers](#)) for the September-December 2016 reporting period.

February 28, 2017- OLIG compiles an updated list of registered Lobbyists and their Employers¹.

March 2017

March 15, 2017- OLIG releases annual lobbying report containing statistical information on registrations and Activity & Expenditure Reports filed during the 2016 calendar year.

May 2017

May 1, 2017- Lobbyists/Employers can begin filing January-April 2017 Activity & Expenditure Reports.

May 21, 2017- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the January-April 2017 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

May 31, 2017- Deadline for filing January-April 2017 Activity & Expenditure Reports.

June 2017

June 5, 2017- Delinquent lists posted to the website ([Agents](#) and [Employers](#)) for the January-April 2017 reporting period.

September 2017

September 1, 2017- Lobbyists/Employers can begin filing May-August 2017 Activity & Expenditure Reports.

September 22, 2017- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the May-August 2017 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

October 2017

October 2, 2017- Deadline for filing May-August 2017 Activity & Expenditure Reports.

October 7, 2017- Delinquent lists posted to the website ([Agents](#) and [Employers](#)) for the May-August 2017 reporting period.

October 31, 2017- OLIG compiles an updated list of registered Lobbyists and their Employers².

December 2017

December 1, 2017- Lobbyists can begin renewing Executive and Retirement System registrations. Lobbyists should only renew engagements for entities they intend to lobby on behalf of in 2018.

December 31, 2017- ALL Executive and Retirement System lobbying registrations expire in OLAC.

January 2018

January 1, 2018- Lobbyists/Employers can begin filing September-December 2017 Activity & Expenditure Reports.

January 16, 2018- Registrations: The last day to renew all Executive and Retirement System registrations in OLAC. Registrations filed after this date will require a signature page along with the filing fee.

January 21, 2018- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the September-December 2017 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

January 31, 2018- Activity & Expenditure Reports: Deadline for filing September-December 2017 lobbying reports.
