



Lobbying Calendar

January 11, 2018

January 2018

January 1, 2018- Lobbyists/Employers can begin filing September-December 2017 Activity & Expenditure Reports.

January 16, 2018- Registrations: The last day to renew Executive and Retirement System registrations in OLAC. Registrations filed after this date will require a signature page along with the filing fee.

January 21, 2018- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the September-December 2017 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

January 31, 2018- Activity & Expenditure Reports: Deadline for filing September-December 2017 lobbying reports. Deadline to submit Executive and Retirement System invoices along with the corresponding filing fee to JLEC.

February 2018

February 28, 2018- OLIG compiles an updated list of registered Lobbyists and their Employers¹.

March 2018

March 15, 2018- OLIG releases annual lobbying report containing statistical information on registrations and Activity & Expenditure Reports filed during the 2017 calendar year.

May 2018

May 1, 2018- Lobbyists/Employers can begin filing January-April 2018 Activity & Expenditure Reports.

May 21, 2018- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the January-April 2018 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

May 31, 2018- Deadline for filing January-April 2018 Activity & Expenditure Reports.

September 2018

September 1, 2018- Lobbyists/Employers can begin filing May-August 2018 Activity & Expenditure Reports.

September 22, 2018- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the May-August 2018 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

October 2018

October 1, 2018- Deadline for filing May-August 2018 Activity & Expenditure Reports.

October 31, 2018- OLIG compiles an updated list of registered Lobbyists and their Employers².

December 2018

December 1, 2018- Lobbyists can begin renewing Legislative, Executive and Retirement System registrations. Lobbyists should only renew engagements for entities they intend to lobby on behalf of in 2019.

December 31, 2018- ALL Legislative, Executive and Retirement System lobbying registrations expire in OLAC.

January 2019

January 1, 2019- Lobbyists/Employers can begin filing September-December 2018 Activity & Expenditure Reports.

January 15, 2019- Registrations: The last day to renew all Legislative, Executive and Retirement System registrations in OLAC. Registrations filed after this date will require a signature page along with the filing fee.

January 21, 2019- Lobbyists/Employers disclosing a Financial Disclosure Statement filer for the September-December 2018 reporting period must provide written notification to the recipient no later than today in order to timely file (a model notification form is available [HERE](#)).

January 31, 2019- Activity & Expenditure Reports: Deadline for filing September-December 2018 lobbying reports.
